Electric rates to be adjusted early 2017



Electric rates are being adjusted to reflect the costs of service provided to customers. The costs of providing safe, reliable energy include ongoing investments in the technology, infrastructure, equipment and the people required to build, maintain and operate the regional power grid. It's also for the wires, meters and services used to deliver energy to homes and businesses.

The California Public Utilities Commission approved an electric rate increase to fund these costs. The reasons for this change include costs for new power lines, upgrades to substations and higher prices forecasted for natural gas. There's also a true-up for actual expenses versus what was projected for 2016.
